Content:	Students get an introduction to the fundamental questions and issues of general international law: (i) entities of international law, (ii) sources of international law, (iii) state rights (status within international law, interstate legal relations, self-determination of peoples) and (iv) basic legal principles of international organizations including peacekeeping and the peaceful settlement of disputes. Additionally, aspects of international humanitarian law, international and regional human rights protection and international criminal law will be highlighted.
Professional competence:	Students will learn about the history, entities and sources of general international law as well as about the relation between international and national law and international criminal law. In addition, students acquire a sound knowledge of the theory of international law, of international institutions relevant for international law and of the latest developments in international law, e.g. in the area of "humanitarian intervention", "preventive self-defense", "problems of democratic legitimacy in international law", "humanity as an entity of international law", etc. Students will learn how to analyze and interpret the network of regulations deriving from different legal sources and to weight their potential for developing future strategies and development opportunities.
Personal competence:	Students acquire analytical skills, critical judgment, precise argumentation skills, transfer skills, self-management, team skills and presentation skills as a result of a structured goal-oriented learning process.

Content:	Students gain an overview of European Union Law (EU law), the European Atomic Energy Community as well as the law of other European international organizations: (i) legal sources of EU law, (ii) division of powers between the EU and its member states, in consideration of the principle of subsidiarity, (iii) the legislative process and other instruments of action, (iv) fundamental freedoms and the non-discrimination principle and (v) the EU budget and the sources of funding.
Professional competence:	Students develop a sound knowledge of EU law, the law of the European Atomic Energy Community and the law of other European international organizations and learn how to relate European law in the narrower sense to European law in the broader sense. They will also become acquainted with the division of powers between the EU and its member states, the legislative processes in the EU, other instruments of action and the EU sources of funding. Students will be able to independently and critically deal with the various legal sources of European law and to analyze and evaluate the legal practices in a detailed manner. Moreover, they will be capable to assess the implications for the respective national law and the further Europeanization processes.
Personal competence:	Students will be able to independently deal with the complexity and heterogeneity of the subject and to interact with their fellow students. They learn that scientific knowledge is, among others, the result of discourses in which they take part critically and constructively, e.g. in the context of teamwork or the preparation of presentations and course/seminar discussions. Students also learn how to independently research, to implement their research results in structures of argumentation and to present, defend and possibly even relativize these argumentations within a discussion.

Content:	Students gain an overview of general and special parts of private international law and the international civil procedure law. The private international law deals with the question of which national state law can be applied to a particular legal relation. The international civil procedure law concerns regulations regarding the civil procedural issues that arise in situations with an international dimension, particularly in relation to the jurisdiction and recognition of judgments.
Professional competence:	Students learn about the history and the judiciary of private international law and civil procedure law. Students will be able to identify problems in the field of conflict of law and procedural law and to develop technically sound solutions by applying corresponding qualifications, connections and references using their knowledge of the conflict of laws.
Personal competence:	Students learn how to deal with contingency and ambiguity and to critically reflect on given solutions. Students also learn how to independently research, to implement their research results in structures of argumentation and to present, defend and possibly even relativize these argumentations within a discussion.

Furthermore, students get to know the relevant rules of the international economic system with a special emphasis on world trade law (WTO law): (i) the relevant legal regime, (ii) institutional WTO law, (iii) rules and principles of market access, (iv) unfair trade practices and (v) WTO dispute settlement mechanisms.
Professional competence:	Students learn about the historical evolution and the significant legal institutions of the existing international trading system and of all relevant areas of international business law. They learn about the different legal sources of international business law with an emphasis on WTO law and acquire a deeper understanding of the legal framework as well as the interaction of different regulatory areas for international business transactions.
Personal competence:	Students acquire analytical skills, critical judgment, precise argumentation skills, transfer skills, self-management, team skills and presentation skills as a result of a structured goal-oriented learning process.
