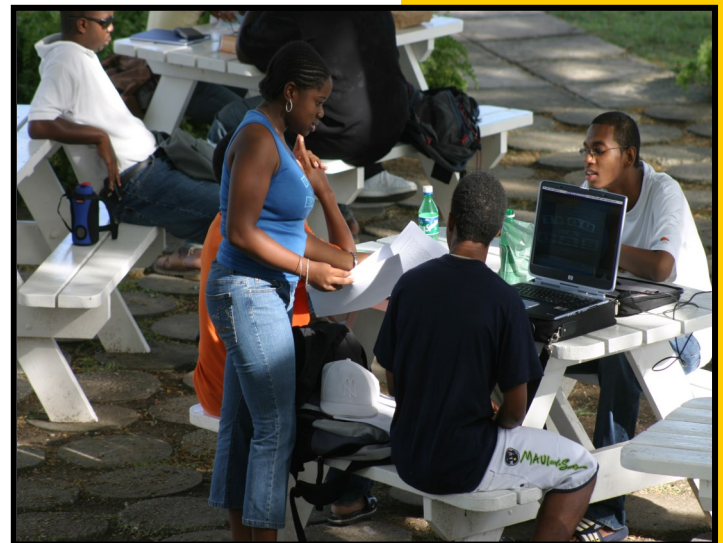

### **Membership Levels:**

**Platinum Members** give a total of at least BDS\$6,500 over at least three years

**Gold Members** give a total of between BDS\$4,001 and \$6,500 over at least three years

**Silver Members** give a total of between BDS\$2,501 and \$4,000 over at least three years

**Bronze Members** give a total of between BDS\$1,000 and \$2,500 over at least three years

### **What Is The UWI Alumni Circle?**

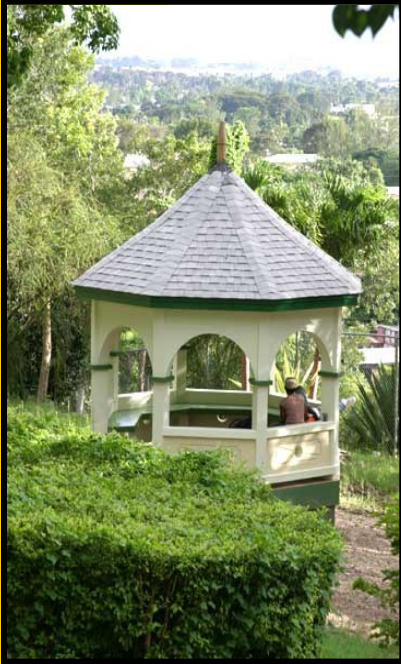
The Alumni Circle is a giving club for University of the West Indies alumni and friends who are committed to ensuring that the Cave Hill Campus continues to provide a world class educational experience in an environment of excellence. Members of the Circle pledge by Deed of Covenant to make a total contribution of a minimum of BDS\$1,000 over a minimum period of three years to the Cave Hill Campus.

Your commitment to the Circle will provide the leadership needed to start a new tradition at UWI. Your gift will inspire others to want to make a difference by helping their alma mater to achieve a margin of excellence. As a member of the Alumni Circle, your name will be engraved in perpetuity in the Alumni Circle in a prominent location on Campus. You will also receive an Alumni Circle lapel pin and polo shirt. In addition, you can receive a tax benefit for your gift.

To become a member of the Alumni Circle, simply complete the Alumni Circle Deed of Covenant (individual or corporate) and return it to: The Office of Alumni Relations, University of the West Indies, Cave Hill Campus, Barbados. Along with the Deed, you should enclose your cheque or bank draft for your first payment or the full amount of your gift. If you are a member of staff of UWI, a monthly salary deduction can be arranged.

We will stamp the Deed of Covenant and forward it to the Department of Inland Revenue, where it will be stamped and registered. We will then return a copy to you. You may then claim your income tax benefit.

A special sub-committee of the Development and Endowment Fund Board, chaired by Mr. Paul Altman, manages the Alumni Circle Fund.



## How Will The Funds Be Used?

Already, a significant investment has been made in beautifying and improving the Campus environment, as well as expanding existing infrastructure and creating new capacity for growth. The funds contributed by members of The Alumni Circle will go towards supporting these and other initiatives. Some of the projects being undertaken, which the Alumni Circle will support are:

**Campus Landscaping and Beautification** – in particular the creation of attractive quiet spaces where students may study or relax and take a break. The Main Library Courtyard, for example, is one area earmarked for development. The placement of attractive benches, artistic sculptures and other landscape features around the Campus and the construction of “gazebos” has already begun. Other sites, such as the Biology Park and the Quadrangle have been earmarked for further development. Goal: US\$500,000.

**University Alumni House** - the Hamilton Court property, located in Blue Waters Christ Church, formerly served as the residence of the Principal of the Cave Hill Campus, but has been unoccupied for a number of years. Our aim is to put the property to productive use and dedicate it as University Alumni House, a venue for formal and informal events including: small conferences, meetings, planning retreats, cocktail receptions, dinners etc. Goal: US\$500,000.

**Expansion of the Law Faculty and Law Library** - The Law Faculty complex has not grown in size since its establishment in the 1970s. In particular, the Law Library has completely exhausted available space. The Library is the premier legal library in the region and includes the most extensive collection of West Indian legislation in existence. If the Faculty is to keep pace with expanded programming and to meet the needs of students and legal professionals around the region, its accommodations must be expanded and modernized. Goal: US\$1,000,000.
