THE LAW REVISION (RECTIFICATION OF OMISSIONS) ORDER, 1984

The Law Revision Commissioner in exercise of the powers conferred on him by section 22A(3) and (4) of the *Law Revision Act* makes the following order:

1. This order may be cited as the *Law Revision (Rectification of Omissions) Order, 1984*.
2. For the purposes of this order,

"revised edition" means the edition of subsidiary legislation published in three volumes and brought into force on the 1st August, 1983.

3. It is hereby declared
 - (a) that the enactments specified in the Schedule state the law in force on the 31st December, 1978, and that those enactments continued in force immediately before the 1st August, 1983;

- (b) that the enactments so specified have been omitted from the revised edition; and

- (c) that in accordance with section 22B of the *Law Revision Act*, those enactments shall be deemed to have remained in force as part of the laws of Barbados as from 1st August, 1983, notwithstanding the provisions of section 12(2) of the Act.
