IUCN BIOPAMA workshop held at UWI

CERMES, a member of the IUCN, kicked off conference partnering for 2013 with the IUCN Biodiversity and Protected Areas Management (BIOPAMA) Regional Workshop for the Caribbean, held from 22-24 January 2013 on the Cave Hill Campus. According to José Courrau of IUCN, the BIOPAMA programme aims to address threats to biodiversity in African, Caribbean and Pacific (ACP) countries, while reducing poverty in communities in and around protected areas. It is financially supported by resources from the intra-ACP envelope of the European Commission's (EC) 10th European Development Fund (EDF).

BIOPAMA combines improving data availability with capacity development to strengthen protected area management. It has two main components: one concerning protected areas, and another dealing with access and benefit sharing. Ultimately, BIOPAMA should lead to better biodiversity conservation and livelihoods options.
